EMERGENCY MANAGEMENT & 911 REPORT

- No action has taken place on the GIS portion of the mapping. No communication has taken place for two months.
- NIMS / ICS training: Are there any changes to report from the County Commission or department heads?
- Commissioner Jones and I attended the "EM-101" class on August 26 & 27. This was an introductory class for new EMs and other local officials. This class brought the On-line courses ICS-100b, ICS-200b and ICS-700a into perspective by allowing us to ask questions about different situation and get answers about what and who to call for help. We also did some tabletop exercises where we had to come up with the answers to mock disasters.
- The State and Local Agreement (SLA) was completed for FFY2015-2016. The current allocation is \$17,234.10.

TRAINING

- Introduction to use of the law enforcement teletype system.
