Dear County Board of Commissioners:

We respectfully submit the following liquid asphalt road oil bid to Hand County.

Our asphalt material will be loaded from our Corson, SD terminal or Sioux City, IA terminal. We request that if awarded any work with the County that you identify which grades and quantities you desire. We will only supply those grades that are specifically identified.

These prices include truck transportation delivery during the 2019 construction season only. One and a half hours are allowed for unloading. Demurrage is \$160.00 per hour after one and a half hours. Equaling \$40 per 15 minutes after 1.5 hours. When Jebro hauls the material a \$100 cancellation fee may be charged. Prices are based on minimum 24 ton loads.

The locations of our terminals ensure timely deliveries of the products at application temperatures. Our prices include both on-site and laboratory (AASHTO certified AMRL Lab) technical assistance with your seal coats to assure maximum value to the taxpayer.

We appreciate the opportunity to service Hand County. Acknowledgment of our bid is appreciated.
