The Hand County Board of County Commissioners met in regular session for a special meeting on September 15, 2021 in the commission chambers. Chairman Gilbert "Gib" Rodgers called the meeting to order at 7pm with the following commissioners present: Wernsmann, Eschenbaum, Jones and Palmer. The meeting was also broadcast live on YouTube and linked to the county's Facebook page.

The purpose of this special meeting was to consider the resolution adopting the 2022 annual budget. The resolution reads as follows: "**RESOLUTION 2021-24 WHEREAS**, (7-21-5 thru 13), SDCL provides that the Board of County Commissioners shall each year prepare a Provisional Budget of all contemplated expenditures and revenues of the County and all its institutions and agencies for such fiscal year and, **WHEREAS**, the Board of County Commissioners did prepare a Provisional Budget and cause the same to be published by law and, **WHEREAS**, due and legal notice has been given to the meeting of the Board of Commissioners for the consideration of such Provisional Budget and all charges, eliminations and additions have been made thereto. **NOW THEREFORE BE IT RESOLVED**, That such provisional budget as amended and all its purposes, schedules, appropriations, amounts, estimates and all matters therein set forth, **SHALL BE APPROVED AND ADOPTED AS THE ANNUAL BUDGET OF APPROPRIATIONS AND EXPENDITURES FOR HAND COUNTY, SOUTH DAKOTA** and all its institutions and agencies for calendar year beginning January 1, 2022 and ending December 31, 2022 and the same is hereby approved and adopted by the Board of County Commissioners of Hand County, South Dakota on this 15<sup>th</sup> day of September, 2021. The Annual Budget so adopted is available for public inspection during normal business hours at the office of the county auditor, Miller, Hand County, South Dakota. The accompanying taxes are levied by Hand County for the year January 1, 2022 through December 31, 2022." County Tax Levies: General County Purposes (10-12-9) \$2,290,469. Mill levy: \$1.508 (\$1.51) per \$1,000 of taxable value. Secondary Roads (Unorganized territory) \$95,287. Mill levy: \$0.554 (\$0.55) per \$1,000 of taxable value. Total Taxes Levied by County: \$2,385,756.
