The Hand County Board of County Commissioners met for their regular year-end meeting in the commission chambers of the courthouse on December 28th, 2021. Chairman Gilbert "Gib" Rodgers was excused so vice chairman Greg Palmer called the meeting to order at 1:00 P.M. with the following commissioners being present: Jim Jones, Jim Eschenbaum, and Luke Wernsmann. The meeting was broadcast live via YouTube and linked to the county's Facebook page.

Upon motion of Jones/Eschenbaum, passed, the **consent agenda** was approved. The consent agenda included the minutes of the December 7, 2021 regular meeting and the payment of the claims & vouchers.

The chair called upon **Auditor DeBoer** to brief them on the year-end financials and transfer of spending authority from the commissioner's contingency budget to the commissioner's operational budget, the only budget to see an overage.

DeBoer explained the expenditure budget report offered in the agenda reflects the expenditures up to the middle of December. It does not reflect the payment of claims approved just moments prior. Based on the auditor's office calculations, a transfer was needed to bring the budget back into compliance. Additionally, up to \$900,000 of general fund revenue is to be transferred to the Road and Bridge Fund (not the highway department). This is a practice used to offset shortages or in this case, increase the Road and Bridge Fund for the coming year and the coming year's expenses. It also prevents the general fund from exceeding the 40% rule enacted by the legislature. To that end, it was moved by Wernsmann/Jones, passed, to approve Resolution 2021-27 which reads as follows: RESOLUTION 2021-27 CONTINGENCY BUDGET TRANSFERS WHEREAS, SDCL 7-21-32.2 authorizes counties to transfer by resolution from the contingency budget to "any other appropriation in which insufficient amounts were provided or for items for which no appropriation was provided." and, WHEREAS, the commissioner's budget experienced shortfalls in budget authority and would be best served by a transfer, to wit: General Fund: Commissioners (101-111); contributing factors: Property & Casualty Coverage: \$8,872.66 overage, Worker's Compensation Coverage: \$8,412.00 overage, Group Insurances: \$6,311.92 overage, Legislative Audit Expenses: \$1875.00 overage, Other operational expenses: \$3150, Total transfer (estimated) within the general fund: \$28,621.58. WHEREAS, \$900,000 was budgeted (GF - 101-911-911) for transfer to the non-general fund funds. The road and bridge fund (201-0-371.00) had a budgeted revenue from transfer in, in the amount of \$900,000 and, NOW THEREFORE BE IT **RESOLVED**, that within the boundaries of state law, the aforementioned transfer of funds from the commissioner's contingency budget (112) to the commissioner's operational budget (111) and, BE IT FURTHER RESOLVED, that as previously budgeted, a transfer of up to \$900,000 may occur between the General Fund (101) to the Road & Bridge Fund (201). All of which being in the best interest of public administration and necessary to carry out the duties and responsibilities of the county. Adopted this 28th day of December, 2021 /s/: Greg Palmer, Vice Chairman. Attest: /s/: Doug DeBoer, County Auditor.

Jim Powell, Summit Carbon Solutions (a subsidiary of Summit Ag), appeared via video to inform and discuss the proposed carbon dioxide pipeline that would cross the northern portion of Hand County. Powell gave a summary of the 500 mile, \$4 billion, steel pipeline that would be used to move carbon dioxide emissions from 31 ethanol plants in five states to the oil fields of North Dakota. The pipeline would cross Hand County and connect the plants near Onida and Redfield. Powell said that they have not received approval from state regulators yet but if they do, they would obtain easements from landowners. Powell said the pipeline would be no less than four feet under the surface and would be within a 50' permanent easement but that during construction the easement would be 100' in width to allow for access and overburden. The land owners would be compensated for the easements and Powell said that the company would provide for crop loss during the years that followed placement.

Commissioner Jones asked several questions about the financial feasibility of the project. Powell said the company does exist to make money and they would do so by contracting with the ethanol plants to move their captured carbon dioxide. They would become eligible for a \$50/ton tax credit and possibly up to \$85/ton should proposed legislation be approved. Powell said that the removal of the carbon dioxide at the plant, at the time of manufacture, makes the profitability for the plant increase because they rid themselves of the biproduct and it should increase the quality of the refined ethanol. Powell said that carbon dioxide is compressed and water is removed. The lines are highly pressurized so the contents become a slurry instead of a vapor. That product is then moved via the pipeline and eventually is deposited about 1 mile under the North Dakota oil fields.

Jay Poindexter, Chuck Martinmaas and Jennifer Poindexter-Runge were present to listen and offer comments. Poindexter questioned Powell about the four-foot burial depth and pointed out that during wet years he has had equipment sink to near that depth. Should that happen and injure the pipeline, who would be responsible? Powell said his company would be. Poindexter-Runge asked about how a 60-degree pipeline would impact roadway crossing during the winter freeze and spring thaw. Would four feet of dept be enough to prevent road heaving or sinking? Powell responded that his company is willing to work with land owners and road districts to find a solution to those concerns. Martinmaas asked about the possible impact a rupture would have on surface and underground water. He also sited that carbon dioxide becomes carbonic acid when mixed. Powell said that a breach in the pipeline could be dealt with and because the vapor would rise and drift way, it would not adversely impact the water. Poindexter also questioned Powell on the difference between what people were told in Redfield's meeting verses what was said today, namely that the easement was going to be smaller than Powell stated today. Powell reiterated that the easements would be for 100' during construction (temporary) and 50' post construction (permanent). Powell added that they would need to have access to do maintenance and respond to emergencies.

The presentation ended with Powell but many questions remained about the benefits and the dangers of the project. Bryan Breitling, Avera Hand County Memorial Hospital and Hand County Memorial Hospital, Inc. (two entities working in tandem) summarized the financial audit report of the HCMH, Inc and then A-HCMH. While providing extensive information on each of the audited phases, Breitling's summary resulted in a report that both the entities providing health care services were able to come out ahead despite some economic and procedural hurdles.

Breitling explained that A-HCMH funds captured above costs are used to purchase equipment, make improvements and to purchase land.

Breitling also touched on the need to replace the ambulance used by the Hand County Ambulance Service. Breitling said the last ambulance was purchased about eight years ago for \$115,000. A new ambulance would cost about \$310,000. The contributions saved from townships is about \$50,000 (those funds were also used to pay for the current ambulance). The current trade-in value of the backup ambulances is \$15,000 which leaves \$295,000 to be raised. Breitling asked for consideration by the county when it comes to projects for the American Rescue Plan Act (ARPA). The county is scheduled to receive \$618,000 (half of which is already in hand) but it can only be used in four areas. Currently the county does not have a qualified use for the funds. If the ambulance was ordered, it would not be built and delivered until 2023.

State Senator Bryan Breitling returned to the commission for additional comment. Sen. Breitling said he had attended a meeting in Highmore where the carbon capture pipeline was discussed. He offered some of the things he had learned during that meeting. Sen. Breitling said that South Dakota will have 16 counties in which the pipeline would be placed, if approved. In this area, it would cross to the northeast from the Onida ethanol plant, across Sully, Hyde and Hand counties. It would then meet up with another mainline in Spink

County. That mainline runs from Iowa into the oil fields of North Dakota. Sen. Breitling said he does not (personally) favor the use of eminent domain to be allowed for private enterprises to secure land on which to build. He said it will be a discussion during the next legislative session.

Auditor DeBoer spoke to the commission about a care of the poor client. The client had received treatment at several different Avera facilities. One of the facilities was requesting payment but the others had not yet made a request. DeBoer was seeking advice on whether to prompt Avera to consolidate the claims or to work on them as separate claims. DeBoer suggested consolidating the claims and the commission, by consensus agreed.

DeBoer then explained to the commission how he attempted to enroll in the Affordable Health Care Act insurance program. This was done to determine whether the application process is fruitful or not and whether it was worth helping care of the poor clients to enroll. DeBoer reported the process took him 70 minutes. At the conclusion, DeBoer, who applied based on a \$14/hour income, was eligible to buy a respectable policy for approximately \$1,700 per month, at \$940 tax credit would be applied each month, leaving \$760 as the monthly premium. For an individual grossing \$2,240 a month, the \$940 premium would leave \$1,300 for housing, food, vehicle and other expenses (before income taxes and other deductions). DeBoer said that if his only access to the internet portal was by telephone, he would have quit the process after five minutes.

The commissioners agreed that the process for applying would better serve if a trained person were to help clients enroll and attempt to secure healthcare. Jan Kittelson, The Miller Press, said she knew of such a person and suggested DeBoer contact them.

Auditor DeBoer requested an executive session to discuss a personnel matter that he did not have authority to resolve. It was moved by Wernsmann/Eschenbaum, passed, to enter executive session, beginning at 4:48 P.M.

At 5:00 P.M. it was moved by Jones/Wernsmann, passed, to have the commissioners return to open session. The following action was taken: It was moved by Wernsmann/Eschenbaum, passed, to reclassify **Tigh Johnson** from probationary to regular employee. It was moved by Wernsmann/Eschenbaum, passed, to appoint Tigh Johnson as the "department head" for the rubble site.

At 5:02 P.M. the meeting was adjourned upon motion of Jones/Eschenbaum and passed. The next meeting of the county commission will be the regular meeting held on January 4, 2022 at 1 P.M.
